# **General Membership Meeting Held on Sept. 12 at PSH**

The meeting began at 4:00 p.m. with Maureen Neville thanking the membership for their expressions of concern. She thanked the officers and Executive Committee for their help in her absence. She then turned the meeting over to the vice-president.

Mike Jaszczak introduced the Staff Development Committee team. He explained that Waiver Days needed a signature from the PEA President. That required signature was not given by Maureen Neville as a result of the motion carried by the membership in the spring. A brief Power Point presentation followed explaining Early Release Days/Waiver Days by the DSDT.

The administration had placed Early Release Days on the calendar in place of Waiver Days for the 2006-07 school year. According to ODE, Early Release Days do not require a signature from the association. The signature was not required because early release day are approximately 1/2 hour shorter than Waiver Days. PEA quickly pointed out that contractually, due to change in the work schedule, teachers would still have to vote to approve Early Release Days. Since the administration was interested in PEA support, Mike Jaszczak was appointed to meet with the administration to discuss the issue. He was able to secure a General Membership meeting on a faculty meeting Tuesday, teacher driven professional development and a full-day teacher driven Waiver Day for next year, should the membership grant their approval.

Some suggested teacher driven topics for the early release days were: Tech Fairs, Shadow/Observe, Content Standards, Team Builders, Unit Collaboration, Assessment, New Techniques.

A motion was made by the DSDT: We move that the President sign off on the current calendar with early release days and any future waiver days that will be teacher driven. A discussion and questions of the motion followed. A vote was taken and motion carried.

The need for volunteers for the Thanksgiving Food Drive was presented. The Staff Recognition Program was presented. Teachers were reminded of the importance of meeting deadlines for Blocks of Credit and Tenure Intentions.

Teachers were reminded to keep the Duty-Free Lunch, DUTY FREE!

Appraisal timelines have been missed by administrators in the past. As a result, they have been thrown out. It is important that this practice continue regardless of whether the appraisal is favorable or unfavorable.

The floor was opened for questions from the membership.

The meeting was adjourned.

## To Eat or Not to Eat? In Other Words, When Do I Get My Lunch?

Our contract calls for a "duty free" lunch. What does that mean to us? Lunch is **your time**, the BOE is not paying you for the time you are at lunch. We want to ensure that you have a duty free lunch well into the future.

Some of you might recall when we were working to the contract last year, members of the community were going to BOE meetings and stating that teachers were not working through their lunch. One person said in anger, "They don't deserve a dutyfree lunch!" Perceptions such as this force us to protect our time. It is very important that you reserve your lunch for yourself. You should not be working with children during that time.

With increasingly busy schedules, sometimes it seems that lunch time the only time to tutor our students. However, we do not want to set the precedent that it is alright to work through lunch. When individuals choose to do something that is not covered by the contract it may become a "past practice." When we file grievances, such past practices may be referenced by the administration as a reason to deny the grievance. What happens in one building certainly influences what happens in others.
